

## Win a 7-night stay near Golden Beach, Thassos

### Terms & Conditions

1. GO THASSOS O.E. (Hereinafter referred to as the Organizer), is organizing a contest on the website <https://www.facebook.com/GoThassosGR/> (hereinafter "the Contest") which aims to select one (1) winner on September 1, 2020. The winner will win a free stay of 7 (seven) nights at the accommodation "[Villa Dina](#)" located in Thassos and specifically in the area of Skala Potamia near Golden Beach, Thassos.

2. The free stay at this accommodation can be selected entirely by the winner as long as they are 7 (seven) consecutive nights within this time period (subject to availability):

05/09 to 30/09 (from the fifth to the thirtieth of September) of the year 2020

3. The maximum number of people who may stay in the accommodation is 6 adults and 2 children. Therefore the winner may choose up to 7 additional people to stay at the accommodation with them.

4. A returnable damage deposit of 250€ must be paid in cash upon arrival at the accommodation. It will be returned if there are no damages at the property on the day of departure.

5. No parties are allowed at the accommodation and the house rules must be followed which will be provided in writing.

6. Your participation in our Contest means that you accept our terms & conditions.
7. The Contest is open to everybody 18 years of age and older, while all employees of the Organizer, their spouses, as well as their first- and second-degree relatives are excluded.
8. Each participant must be registered on Facebook, must go to the Free Giveaway Post on the Organizer's Facebook page, like the post and leave a comment under the post mentioning who you will bring with you if you win. Each participant must also complete the [Sign Up Form](#) and may only participate once.
9. The name of all the Participants will be registered in a numerical list by the Organizer. The draw will be conducted using electronic means (<http://www.randomizer.org>) which will ensure an unbiased, random selection while preventing human intervention in the process of selecting the winner. The name corresponding to the randomly selected number will be the winner of the contest.
10. The duration of the Contest is set from **12:00 on 25/08/2020 until 23:59 on 31/08/2020 (GMT +3)**. The Organizer reserves the right to extend or reduce this time for a reasonable cause provided that it will publish this change in an appropriate manner.
11. The draw will take place on **01/09/2020** and will pick 1 (one) winner and 2 (two) runners-up. The winner and the runners-up will be announced with a comment below the corresponding post on the Organizer's Facebook account.
12. The Organizer will contact the winner with a private message to establish the specific dates of the 7-night free stay. If the winner does not respond to the message of the organizer by 03/09/2020 at 23:59 pm, they will automatically forfeit their right to the prize and the Organizer will be released from any

obligation they undertook towards the winner in relation to the prize. In case this happens, the winner will be replaced by the first runner-up, who will be informed with a private message by the Organizer.

13. The prize is non-transferable and non-exchangeable. Its redemption is exclusively for the winner of the Contest and can only be redeemed by the winner in the form it was originally intended.
14. Participants give their consent to the Organizer for their personal data to be used for the purposes of the Contest. Participants also give consent for the retention and use of their contact information by the Organizer to send future updates on new contests, offers, promotions, and more. The Organizer promises the safe and responsible storage of the Participants' personal data and in any case, any participant can contact the Organizer to receive any information about their personal data, to request any modification, restriction, partial or total deletion.

19. The Organizer will be entitled to disqualify a participant if there are indications or suspicions that there has been a violation or circumvention of any of the terms of the Contest.
